## ACTION ITEMS

### 9.1 BUSINESS: Proposed High School Attendance Boundaries to be Implemented for the 2021-22 School Year With the Opening of Liberty High School

Dr. Fred Good gave a brief presentation on the proposed four high school attendance boundary alternatives.

The following public comments were received:

Menifee School District Board Member, Kenyon Jenkins, stated that he appreciated Trustee Araux's comments regarding the opportunity for the public to give their input prior to making a decision. Mr. Jenkins commented that he fully understands that the Board has the power to adjust boundaries but at the same time it affects families directly and that Menifee has over 10,000 students in their district and that it is thousands of families that are going to be affected by the change. He stated that if everyone has a better understanding of the information than there is a better acceptance. Mr. Jenkins commented that the public was given the first opportunity to speak on December 18th which is a prime time for everyone gearing up for Christmas and no one is paying attention to anything else. The second opportunity given to the public was that evening but it was also a decision making time as well. He asked the Board to delay the vote and give everyone time to look at the options presented and requested that they give Menifee School District the common courtesy and meet with them and bring them into the fold of what Perris Union High School District is doing.

Mr. Jenkins stated that Menifee can utilize their systems to communicate with their families and constituents to let them know what is going on and get feedback from them and forward the information to Perris Union High School District. He stated that he is aware that the state gave the District money to finish Liberty High School so the money from Measures T and W can be used for other aspects that can offset the future costs of

busing expenses. He also suggested that the District approach the builder of the La Ventana community to see if they are willing to do a land lease for nine years and build some buildings for use for something else.

Menifee School District Board Member, Jackie Johansen, stated that she was grateful for some of the comments that were made that evening along with Dr. Good's. She also stated that she hopes that Menifee School District and Perris Union High School District can meet and make things work for a common group of students. Ms. Johansen stated that she had concerns regarding the proposed boundaries which will separate a small group of students that have been together since TK and that the social/emotional health of kids is the hottest topic out there. She stated that the proposed boundaries are not good for the Menifee community and that the current transfer policy does not include busing and additionally there have been many instances when students are not able to transfer to Paloma because it is overcrowded. Her suggestion is that the boundaries are drawn the right way the first time.

Ms. Johansen stated that she was glad the District did another study session but her concern was that the public didn't know about the meeting. She heard about the study session after the fact from reading it on Menifee 24/7. She requested that the Board table the item for a different meeting and suggested that the small group of students are not separated and are able to attend Liberty High School. Ms. Johansen thanked Dr. Good for all the work he has done. She feels that Perris Union High School District would lose students to surrounding charter schools if Menifee students are not able to attend Menifee schools.

Menifee School District Board Member, Bob O'Donnell, stated that Menifee School District brought a contingent of board members to speak with the District because everyone is working toward the same thing which is students. He mentioned that he did not hear about the proposed boundaries until Jackie Johansen let the Menifee board members know that she attended the meeting on December 18th. He feels that the Menifee community has been left out and thinks it is important to have their input before making a decision and suggested that the item be pulled and voted on at a later date. Mr. O'Donnell stated that Liberty High School is something that the community of Menifee has waited a long time for and to cut out a part of the community that will not be able to attend that school is going to have a dramatic effect. He feels it is important that students are able to attend schools with kids they have gone to school with and Alternative No. 2 would be better for the Menifee community.

Community member, Garry Lingafelter, stated that he was going to rehash what he spoke about at the December 18th board meeting. He mentioned that when the bond measure came up it was a big deal for the Menifee community because Paloma Valley High School was the only high school that served most of the community with the exception of some students going to Heritage High School. The Menifee community saw Liberty High School as a great opportunity that would accommodate students of Menifee. Mr. Lingafelter stated that the proposed boundaries will not allow the Heritage Lakes community attend Liberty High School. He stated that the community has a huge problem with the proposed boundaries and that there are many families that will be sending their kids to charter schools once they finish middle school if they are not allowed to attend Liberty High School.

Mr. Lingafelter stated that he is happy that the District's current policy allows students to transfer from one high school to another within the District but it's contingent upon the enrollment at that particular high school. He mentioned that if Menifee was to unify the community of Heritage Lakes will not be allowed to attend Liberty High School and his community is composed of doctors, lawyers, nurses, and fire fighters that push education on their kids and want them to be able to continue to grow in an atmosphere that supports education. He asked the Board of Trustees to vote in favor of the alternative boundaries that will allow the Heritage Lakes community to attend Liberty High School.

Community member, Whitney Heath, stated that she was a little bit curious because a number of the proposed alternatives are encompassing some of the Murrieta students that are in Spencer's Crossing instead of the boundaries being moved to encompass the Heritage Lakes community. Ms. Heath stated that on January 11th an article was published on Menifee 24/7 that stated that the Menifee School District is going to push for unification and when that takes place with the current proposed boundaries the Heritage Lakes community will not be allowed to attend Liberty High School and will have to attend Heritage High School. She mentioned that a lot of other parents in her children's classrooms have voiced the exact same concerns that she has but are unable to attend the meeting. Ms. Heath asked that the Board of Trustees reach out to the community before voting.

The following Board of Trustees' comments were received:

Trustee Nelissen stated that community input is very important and suggested that Menifee School District host a Town Hall meeting at Bell Mountain Middle School if they were willing to and that would give the community an opportunity to voice their opinion and bring any new ideas forward.

Trustee Freeman stated that he agreed with Trustee Nelissen.

Trustee Araux stated that he agreed with Trustee Nelissen and that the District needs to take into consideration all factors before making a decision.

Trustee Stafford stated that the District needs to get the input of the community prior to making a decision.

#### **10.2 District Update by the Superintendent**

The Superintendent reported on the following:

- Superintendent, Grant Bennett, stated that the second semester started off great and that the M&O crews did an amazing job cleaning up the schools during the break .
- Paloma Valley High School's ESports team competed on January 11th in the championship round and received fifth place out of eighty schools .
- PALS held a Ribbon Cutting Ceremony earlier in the day for their community garden in collaboration with the City of Perris. There are currently six school sites that have a community garden which allows students to grow vegetables, trees, etc.
- Mr. Bennett introduced, and congratulated, the following Districtwide Employees of the Year: Lee Alfred, Certificated Administrator of the Year; Audrey Mitchell, Classified Administrator of the Year; Brenda Arenas, Confidential Employee of the Year; Jedidiah Butler, Site Support Employee of the Year; Maurice Njuguna, Classified Employee of the Year; and Anthony Maldonado, Teacher of the Year.
- Mr. Bennett thanked Kirk Skorpanich and Nick Hilton for doing two Guest Teacher trainings during winter break.
- Lastly, Mr. Bennett is starting a Superintendent's Student Advisory Council Committee at each school site and will be meeting with students along with Dr. Newman. Students will have the opportunity to share their concerns and ideas of what they would like to take place at their school sites.

### **10.4 CSEA President Josh Rushing**

CSEA President, Josh Rushing, wished everyone a Happy New Year. He stated that he has some concerns regarding Consent Item 12.10 which is in regards to hiring a firm for thirty-six thousand dollars for a thirteen week contract to inventory the Districts assets. Mr. Rushing stated that prior to working for the District he was a warehouse manager and did inventory for a multimillion dollar company. He stated that inventory should not be done once it has been missing and why hire a company for thirty-six thousand dollars when the district can purchase an inventory program for eight thousand dollars and have a ten month employee do the job for less than thirty-six thousand dollars. Josh stated that every time that something comes up or a task needs to get done the District hires outside firms instead of using current employees to get the job done for way less money especially due to the current financial problems the District has.

### **10.5 PSEA President Jason Miller**

PSEA President, Jason Miller, wished everyone a Happy 2020. Mr. Miller stated that he is fond of the saying "You cannot put students first by putting the teachers last." He stated that PSEA members need to get a separate education on how their job works, aside from doing their job. PSEA's role is to look out for intricacies of just having the job of teaching so that their educators can focus more on doing the job of teaching. Jason introduced the PSEA Executive Board: Vice President, Debbie Georgianna; Second Vice President, Kim Freeberg; Secretary, Melanie Woodard; Director of Ethnic Minorities LGBTQ, Myshia LeBoss; and Treasurer, Gary Stone. He also mentioned that there are close to twenty plus PSEA site representatives spread amongst the different school sites that work with local site administration.

### **10.6 Comments by the Board of Trustees**

Trustee Nelissen thanked the student representatives for sticking around and having to wait during the long process of the board items. He thanked the community members who took the time to come out and speak regarding the boundary issues and asked Mr. Jenkins to thank the Menifee board members that came out as well. Trustee Nelissen commented that he hopes everyone is having a good start in 2020 and wants to finish out the school year strong.

Trustee Freeman asked the student representatives that were present to make note about what Superintendent Bennett stated in regards to the Student Advisory Council Committee and encouraged them to get involved and to get others involved so that they have a say of what goes on at their schools and in their community.

Trustee Araux wished the student representatives present and their families a Happy New Year and asked the students to continue to work hard and continue to study this semester. He mentioned there are some upcoming tests during the second semester that students will be taking including ELPAC, CASP, and AP tests. He asked that students continue to focus on meeting the high school graduation requirements.




