### 9.2 District Update by the Superintendent

- The Superintendent introduced Perris High School teacher, Rachel Dow and her students, who shared information and a video regarding the Sports Challenge with the Board and invited them to the event.
- Perris High School senior, Sandra Garcia, was awarded a \$50,000 scholarship by the Moreno Valley Elks Most Valuable Student Scholarship program.

- Mr. Bennett reported that he attended the Menifee Valley Council PTA Reflections Award Night and 14 Perris Union High School students were recognized in the areas of literature, visual arts, and special artist.
- Mr. Bennett also recognized Candace Reines, Deputy Superintendent of Business Services, who was selected by ACSA Region 19 as the Business Service Administrator of the Year.
- The Superintendent shared that he attended the IACUE Techfest at Clearwater Elementary School and Perris Union High School District had more staff presenting than any other district.


