4.1 Principal's Update

Dr. Milosavljevic shared the following with the Board:

- He thanked the Board and Cabinet for their continued support.
- Dr. Milosavljevic also shared that CMI is slated to receive a 100 percent graduation rate. This will be the largest graduation class with 116 cadets. Part of this is due to being able to offer more courses, therefore not losing as many students.
- The enrollment numbers are looking stronger and the school is still using the lottery system for acceptance. Dr. Milosavljevic reported that there are over 200 cadets attending from outside the Perris area, some as far as Colton and Redlands.
- Attendance is over 96 percent. The suspension rates are also lower. This is due, in part, to creating a Military Review Board. Before a student is suspended, they meet with the Military Review Board for behavior intervention.
- Finally, Dr. Milosavljevic reported that staff morale is as strong as could be. He is also proud of CMI's guardsmen who have been providing meals to families in the community.


